
THE VIA REGIA was an important trade route of the Middle Ages. In 2005 it was awarded the title of a "European Cultural Route" by the Council of Europe. The journey from Bayreuth to Lviv exemplifies the violent border shifts and changes in border regimes during the 20th century in Central Europe as well as zones of east-west-contacts.

CONCEPTUAL TALKS on three days in Bayreuth on topics such as territoriality and bordering laid the foundation for later discussions with experts and joint fieldwork. Lectures at Iwan-Franko-University focussed on the current geopolitical situation of Ukraine and cross-border-cooperation.

CIVIL SOCIETY INITIATIVES like Galicja Jewish Museum (Kraków), Meetingpoint Music Messiaen e.V. (Zgorzelec-Görlitz), Dom im. Edity Stein (Wrocław) gave insight into the practices of borderwork by citizens, whereas the administration of the Lviv Oblast (Department for International Relations) showed government attempts of CBC.

FIELDWORK was carried out by students in trinational teams during the journey at each stage of the project. Relying on the concept of place and using methods of empirical research various data was collected.

PRESENTATION of the groups' results took place at the "House of Science" in Lviv in the presence of Marian Orlikowski, consul general of the Republic of Poland.
